



## RV Parking Policy

Overnight parking is only permitted with prior approval from the Tournament or Valley-Wide Recreation and Park District. Please read the following rules and complete the information below. One week prior to tournament start date, please complete one of the following:

- \* Motor homes/RV's only permitted to park in dirt fields behind ball fields.
- \* No charcoal grills, fire pits or open fires permitted.
- \* Facility is secured nightly by 11pm; you will be locked in and unable to leave until the following morning.
- \* RV's/Motor homes are not permitted to park in paved parking areas.
- \* There are no pads or hook ups for RV's/Motor homes.
- \* All owners park at their own risk.
- \* All trash and waste must be taken off site.
- \* No alcohol or smoking permitted at Valley-Wide Recreation and Park District facilities.
- \* RV Parking: Pre- Sale \$15 per day or \$75 per week by July 23 the day of tournament \$20 per day or \$80 per week
